

# STYLE ACRE 200 CLUB

---

## RULES

1. The name of the draw is the 200 club ("the lottery") regardless of the number of shares.
2. The purpose of the lottery is to raise funds for the sole benefit of Style Acre.
3. The lottery will be administered by a Promoter appointed by the Trustees of Style Acre
4. Prizes will be set on a pro rata basis of the actual numbers of participants at the time of each draw. The lottery shall run from 1<sup>st</sup> June to 31<sup>st</sup> May each year. There will be 1 prize each month, the total value of which will amount to 10% of the sales each month. . I.e. if 200 shares sold for £10 each, £200 will be paid out.
5. The lottery will be open to anybody aged 16 or over.  
A purchaser of a share becomes a participant in the lottery.  
Participants are entitled to hold any number of shares.
6. The number of shares in the lottery shall be unlimited and each share shall be allocated a unique number. The purchaser will be informed of their number(s). Tickets however will not be issued.
7. The cost of each share is £120 per annum (£10 per month).

All participants must pay either annually or monthly in advance, by Standing Order or by cheque (cheques made payable to Style Acre.)

8. There shall be a draw made in each calendar month on the last Friday of the month.

All participants are entitled to attend the draws, which must be held in the presence of at least 3 members of the Senior Management Team on such occasions and times as the Promoter shall deem appropriate if the last Friday of the month is a bank or public holiday.

Prize winning numbers will be drawn at random.

9. Winners will be paid by cheque, which will be sent to the last known address held by the Promoter. It is the responsibility of the participant to advise the Promoter of any change of address. Any prize cheque not cashed within 6 months will be deemed a donation to the charity.

10. The Promoter will not pay a prize to any participant other than the purchaser of a winning share.
11. No lottery participant will be included in the draw if the annual or monthly payment has not been received. It is the responsibility of each participant to make sure they have paid their subscription. The Promoter reserves the right to reallocate any number where payment has not been received.
12. Participants can cancel their entry in the lottery at any time by giving one month's written notice to the Promoter. Any decision by the charity to end the lottery will also be by one month's notice to all participants.
13. Under no circumstances can subscriptions be refunded except where the promoter ends the lottery in which case people who have paid annually will be offered the remaining proportion of the annual payment as a refund..
14. The Promoter will determine any dispute.
15. The lottery is registered with South Oxfordshire District Council.

An appeal may be made to the charity's Chief Executive Officer whose decision shall be final.

16. Style Acre may amend or vary the rules of the lottery at any time. The rules of the lottery will be available via the charity website:
